AHERA three year re-inspection performed at Lake View Elementary School 17451 Zeider Lane, Huntington Beach, CA 92647; HSA Project Number 150175LA.

At your request, Health Science Associates (HSA) performed a three year re-inspection to assess the presence and condition of the existing asbestos containing building material (ABCM), asbestos containing material (ACM) or asbestos containing construction material (ACCM) and incorporate findings to update the OVSD Asbestos Management Plan at the referenced location in accordance with the AHERA re-inspection protocol as outlined in 40 CFR Part 763, Subpart E. The re-inspection was performed by Mr. Lucas H. Wallin, Certified Asbestos Consultant (CAC Cert. No. 14-5193).

Between August 2014 and May 2015, the removal of ACBM/ACM within the main building and kindergarten occurred as part of a major modernization project. This three year re-inspection was conducted at the conclusion of said modernization project. ACBM/ACM removed included fireproofing, flooring materials (all layers), asbestos-cement (AC) panels, and thermal system insulation (TSI), as identified prior to the abatement. A description of all remaining materials, locations, and estimated quantities are summarized in Appendix B - ACBM/ACM Inventory. For further information regarding sampled materials and their analytical results, refer to Appendix F - Previous Limited Asbestos Bulk Surveys and Existing AHERA Documentation.
